

## **DRIVE IN CAROLS BY CARLIGHT FAQs**

### **Where is Carols by Car-light?**

Huntingdon Racecourse

### **When will it happen?**

Saturday 19 December 2020.

### **What time will it be?**

4pm – Please aim to arrive within your allotted arrival slot as selected at the time of buying your ticket

8pm – Please aim to arrive within your allotted arrival slot as selected at the time of buying your ticket

### **How much does it cost?**

£10 per car plus an Eventbrite admin fee charged at purchase. The only limit is the legal occupancy of your car. Please do not car share with people outside of your household.

### **Who is organising “Carols by Carlight”?**

Godmanchester Baptist Church.

### **What do I need to bring?**

You may wish to bring blankets – it is winter and car engines will need to be off

### **Can I leave my car?**

No.

### **Can I bring children?**

Yes. Children will be given an activity pack on arrival

### **How will I hear the service?**

The service will be accessed through an FM transmitter via your car radio

### **Do I leave my car running / lights on / heat on?**

All vehicle engines and lights must be switched off during the service.

### **What if I arrive late?**

Late arrivals may be refused entry. Please aim to arrive at your allocated time.

### **What happens if I need help during the service?**

Stewards will be located across the car park who will help you if you require assistance. Attract their attention by putting your hazard lights on.

### **What if I need to leave during the service?**

Vehicles must remain stationary in the car park until the service has ended and stewards have given drivers the signal to start engines and exit. If, however, there is an emergency please put your hazard lights on and a steward will help you.

### **What kind of vehicle can I bring, and how many people?**

- Standard passenger vehicles only.
- Party size will not exceed the number of legal seats in the vehicle.
- Maximum vehicle occupancy of 7 people.
- Please do not car share with people from outside of your household in line with Government guidance.
- Larger passenger vehicles such as 4 x 4s may be placed in the car park towards the back, to avoid blocking the views of others.
- Vehicles NOT permitted - oversized vehicles (over 2 m in height), motorbikes, mopeds, coaches, buses (including minibuses), RVs, limousines, commercial vehicles such as vans, light goods vehicles, heavy goods vehicles and vehicles with trailers.

### **What happens at the end of the service?**

Refrain from starting your engine until instructed by the stewards who will direct drivers to the exit.

### **How do you ensure our safety?**

All events are designed to comply with Government official social distancing guidelines.

- Cars are parked in the car park with an empty space either side.
- The only time you can leave your vehicle is to use the toilets in an emergency.

**WARNING:** It is imperative that attendees follow the social distancing guidance at all times. Stewards will be monitoring all attendees to ensure the code is not breached.

### **Are toilet facilities available? Where are they?**

Toilets are available in an emergency situation.

- Toilets are cleaned regularly.
- Toilet facilities will be managed to maintain social distancing.
- A steward will direct attendees to and from the toilets maintaining a social distance of no less than two metres in both directions.
- We strongly recommend using the facilities at home before coming to the event.

### **What do I do if my battery goes flat?**

Please wait until all other vehicles have left the car park and a steward will come and assist you.

### **Important Welfare Information**

Covid-19, often referred to as coronavirus, is an infectious disease that can result in a serious and potentially fatal illness. There is a risk of the transmission of Covid-19 in any environment where people come together. This risk increases in enclosed spaces and with increased numbers of people. The World Health Organisation (WHO) has advised that the elderly and those with underlying medical conditions are more vulnerable. Further information can be found on the WHO's website:

Whilst Drive in Carols will be adopting enhanced safety measures to help attendees stay safe, the risk cannot be completely eliminated. Upon attending a service, you assume all risk associated with Covid-19. You will also be expected to abide by all Government guidance aimed at preventing the transmission of the virus and follow all directions provided by Drive in Carols.

You must not attend if you believe that you may have been infected by Covid-19.

Failure to comply with these measures shall entitle us to remove you from the service.

Please contact the Event Safety Officer for more information on the safeguards being implemented.

All events are subject to the latest Government guidance rules to manage the transmission of Covid-19. Everyone attending is expected to adhere to the guidance.

**The following individuals must not attend the event**

- Any individual displaying the symptoms of Covid-19 (new persistent cough, high temperature, loss of taste or smell).
- Any individual who is self-isolating either due to displaying symptoms as above for 10 days, or any member of their household who is self-isolating for 10 days.
- Any individual who has been instructed by the relevant contact tracing authority to isolate. We advise the following individuals not to attend the event
- Any individual who has been informed that they are extremely clinically vulnerable and that they should be shielding.
- Individuals who live in the same household as an individual who is extremely clinically vulnerable.
